Policy of the Cultural Activity Cell, IQAC Bijni College, Bijni

Introduction:

Cultural Activity Cell, IQAC, Bijni College, Bijni is constituted by Co-Ordinator of IQAC, and Principal of Bijni College, Bijni with the aims to promotethe cultural upliftment of the students of Bijni college towards diverse local as well as national culture. It will nurture creativity, cultural talents and holistic development among the students by providing platform and facilitating diverse cultural activities and fostering participation in inter-college and inter-university cultural events as well as competitions.

Structure:

The cell shall consist of one Convenor and 12 members from the faculty of Bijni College appointed by IQAC and Principal of the college. The convenor of the cell will lead the cell and other members of the cell will co-ordinate with the convenor.

Objectives:

- To collaborate with external cultural bodies and experts for workshops, seminar and events that enriches the cultural experience of students.
- To invite local artists and cultural figures to inspire students for exposure to different forms of culture.
- To identify and nurture student talent in various cultural domains like music, dance, drama etc.
- To represent Bijni College at inter-college and inter-university cultural competitions fostering students a spirit of healthy competition and collaboration.

Responsibilities:

All the members and convenor will be equally responsible in planning events, identifying students' talents and organizing cultural activities. The convenor will lead the cell and all the members will co-ordinate and support the convenor in taking decisions and executing the plan and policy.

Stakeholders:

The primary stakeholders of the cultural activity cell are all the bonafide students of Bijni college. The concerned authority will support cultural initiatives by providing resources and approval for events. The cultural activity cell will be lead by convenor of the cell and members appointed by Co-ordinator of IQAC and head of the institution.

Code of Conduct:

Participants in any cultural programmes must adhere to the code of conduct of the college and ensure safe, respectful and harassment free environment during all cultural programmes and activities.

Funding and Resources:

The cell will seek financial help from the IQAC for organizing cultural events and supporting the students' participation in external competitions as and when needed.

Reporting and Accountability:

The cell is accountable to maintain proper records of activities and students' participations in various cultural competitions throughout the year. The convenor of the cell will submit an annual report to the IQAC.

Review and Amendments:

The policy will be reviewed annually by IQAC. Amendments will be made if necessary. The Co-ordinator of IQAC and Principal of the college can jointly reconstitute and dissolve the cell at any time.
