2. The joint venture is committed to conduct at least 2 surveys yearly & other programs (awareness etc) for the benefit of the society on various social issues & problems faced by the inhabitants of the area.
3. The department of economics is committed to provide support in planning, execution & summarizing the findings of the survey undertaken in a brief report.
4. The department of economics are also committed to provide manpower support in the form of students of the department for smooth conduct of the survey.
5. The NGO is committed to provide physical support for field survey & also creating awareness in the society regarding the aims & objectives of the survey.
6. While conducting the survey, the aim of the survey is not to propagate any political agenda causing harm to

any caste, religion or community or selfish interest. The subject of the program will be selected by a joint decision of both two parties.

7. The parties agree that it and its, associates/affiliates shall not directly or indirectly negotiate with any other party in connection with any other surveys. It is also agreed that the parties shall not negotiate with any other party for profit motive.

All notices and correspondence shall be in writing and may be sent by sending the same by registered post or by email to the other side, at its address set forth herein below or at such other address, as such other party may subsequently notify. All such notices shall be deemed to have been given or served when delivered.

12. In the event of any difference or dispute arising out of the interpretation or in connection with this Memorandum, the parties shall consult each other and both the parties will decide the matter by holding a meeting either at Bijni or at Bongaigaon.
13. The obligations of the parties under clauses of this Memorandum shall survive, the termination or expiration of this Memorandum.

It is hereby expressly made clear that the intention of the parties is not to create binding agreement between the, parties and no party shall have the right to file claim against the other party for breach of the terms of this Memorandum. The parties understand that neither this Memorandum, gives any right to any party nor it creates a partnership, joint collaboration or any other entity.
